

Terms & Conditions for #YourKFFBetterWithPepsi Contest

These Terms and Conditions ("**Terms**") govern the #YourKFFBetterWithPepsi Contest ("**Contest**") organised by **Etika Sdn Bhd** (Company No. 197401000344 / 16347-W), the official distributor of Pepsi in Malaysia (hereafter referred to as "**the Organiser**").

By participating in this Contest, you ("Participant") agree that you have read, understood, and accepted these Terms, and you agree to comply with them.

1. Eligibility

1.1 The Contest is open to all **Malaysian citizens** aged **15 years and above** at the time of entry.

1.2 Participants aged **15 to 17 years** must obtain **parental or legal guardian consent** prior to entering the Contest. The Organiser reserves the right to request written proof of such consent at any time.

1.3 Employees, representatives, and immediate family members of the Organiser, its affiliates, advertising and promotion agencies, campaign partners, event organisers, and their immediate family members are **not eligible** to participate.

2. Contest Period

2.1 The Contest will run from 00.00.00 on **22 July 2026** and shall close on **23.59.59 on 14 August 2026**, inclusive ("**Contest Period**"). Any contest entries received outside the Contest Period will automatically be disqualified.

2.2 The Organiser reserves the right to modify the Contest Period at any time without prior notice to any party.

3. How to Participate

To enter the Contest, participants must complete the following steps:

3.1 Purchase any food item at the **Kuching Food Festival (KFF)** and pair it with any **Pepsi can**.

3.2 Take a **creative photo or video** of the meal with **can**.

3.3 Upload the said photo or video of the meal with the **Pepsi can** on **Facebook or Instagram** and ensure that the account is set to a **public account**.

3.4 Include the **hashtag #YourKFFBetterWithPepsi** and tag either **@PepsiMY** on Instagram or **@PepsiMalaysia** on Facebook.

3.5 Each post is considered **one entry**. Participants may submit **multiple entries** but are only eligible to win **once** throughout the Contest Period.

4. Prizes & Winner Selection

4.1 Participants stand a chance to win a portion of Ringgit Malaysia Fifteen Thousand (**RM15,000.00**) in **cash prizes**. Five (**5**) winners ("**Winners**") will be selected **weekly for the total of three (3) weeks**. Each Winner will receive Ringgit Malaysia One Thousand (**RM1,000.00**). Fifteen Winners will be selected throughout this Contest Period.

4.2 Winners will be selected based on the **creativity, originality, and adherence to the Contest mechanics**.

5.1 Winners will be contacted via **Direct Message (DM)** on Facebook or Instagram **within seven (7) days** of the announcement.

5.2 If the selected Winner **does not respond within fourteen (14) days** from the date of the DM, the Organiser reserves the right to **forfeit the prize** and select an alternate winner. The Organiser will not be held liable in the event the Winner cannot be contacted for any reason whatsoever. The Organiser's decision in selecting the Winner shall be final and no correspondence will be further entertained. The Organiser reserves the right to substitute any of the prize with a prize of equivalent value in the event the original prize offered, is, for any reason whatsoever, is no longer available.

5.3 Participants under the age of 18 must have a **parent or legal guardian** assist in the **prize claim process**, including the provision of valid identification and bank account details for prize disbursement.

9. Disqualification

The Organiser reserves the right to disqualify any Participant who in the sole opinion of the Organisers are to be:

- * Containing lewd, vulgar, defamatory content;
- * Violating any of the Terms herein;
- * Using inappropriate, offensive, or plagiarised content;
- * Attempts to manipulate the outcome or mechanics of the Contest.

10. Limitation of Liability

10.1 The Organiser, its agents, sponsors, and affiliates shall not be liable for any **loss, damage, or injury** incurred by participants as a result of their participation in the Contest or use of the prizes.

10.2 The Organiser is not responsible for any technical issues, failed submissions, or internet disruptions that affect participation.

11. General

11.1 The Organiser reserves the right to amend these Terms, including Contest mechanics, judging criteria, or duration, at any time without prior notice. By participating in the Contest, Participants are taken to have read, understood and agreed to be bound by the Contest Terms & Conditions. The Organiser reserves the right to vary and/or delete any of the Contest Terms & Conditions at any time without prior notice to any party and the Participants hereby agree to be bound by such variation and/or deletion.

11.2 In the event of any conflict between these Terms and promotional materials or announcements, these Terms shall prevail. The Organiser reserves the right to, at its sole discretion, modify the Contest mechanism, vary, withdraw, suspend or terminate this Contest at any time at its sole a without prior notice to any party.
